EC asks CEO to take action on Jharkhand BJP's video

NEW DELHI

Taking a serious note of complaints from the Congress and the Jharkhand Mukti Morcha against a "misleading and malicious" video posted by the BJP in Jharkhand on social media platforms, the Election Commission on Sunday directed the State's Chief Electoral Officer to direct the party to take down the post.

It has sought an explanation from the BJP for the alleged violation of the provisions of the model code of conduct by posting the

video.

The Chief Electoral Officer has been directed to immediately take action in the matter and get the objectionable posts removed from social media platforms expeditiously in coordination with the designated authority in the state under the IT Act.

The JMM and Congress, in their complaint to the poll panel on Sunday, objected to the "misleading and divisive" video. The complaint said the video was rife with baseless allegations and falsehoods to unduly influence voters by creating a feeling of hatred and enmity, against the JMM and its leaders.

EC admits to data errors in J'khand polls

Ranchi: EC acknowledged on Sunday errors in the election data released for the ongoing Jharkhand assembly elections, calling them "typographical errors".

The mistakes pertained to polling station details, electorate figures, and demographic data for various constituencies during the first phase of the elections held on Nov 13 and the upcoming second on Nov 20. Upon discovery, the CEO's office admitted to the

errors, attributing them to clerical mistakes and asserting that corrected figures released on Oct 17 and 22 were accurate. A statement from the EC media cell apologised for the errors and assured that the corrected data for the first and second phases of the elections were error free.

JMM spokesperson Supriyo Bhattacharya said. "We have lost faith in the commission and are worried if they are handling things properly." In contrast, BJP downplayed the errors as clerical.
