



the first time in the history of the world, the people of the United States have been called upon to determine whether they will submit to the law of force, or the law of the Constitution. We shall not shrink from that great responsibility.

It is now less than two months since the election of Abraham Lincoln as President of the United States. In that time, the Southern states have seceded from the Union, and the Federal troops have been driven from the capital city of Washington, D.C., and from the Federal fort at Sumter, in South Carolina. The Southern states have also passed ordinances of secession, and have established their own government, known as the Confederate States of America.

The Southern states have taken these actions in response to the election of Abraham Lincoln as President. They believe that Lincoln's policies, particularly his opposition to slavery, threaten their way of life and their right to self-government. They also believe that the Federal government has violated the Constitution by sending troops to defend the fort at Sumter.

The Northern states, on the other hand, believe that the Southern states have no right to secede from the Union. They believe that the Union is a permanent and unbreakable bond between the states, and that the Southern states have no right to break it. They also believe that the Federal government has the right and duty to defend the Union and to protect the rights of all citizens, regardless of their state of origin.

The situation is now at a critical point. The Southern states have declared war on the Federal government, and the Federal government has responded by sending troops to defend the Union. The outcome of this conflict will determine the future of the United States, and the fate of millions of people.

We must therefore decide whether we will support the Southern states in their efforts to secede, or whether we will support the Federal government in its efforts to defend the Union.
