the first time in the history of the world, the people of the United States have been called upon to determine whether they will submit to the law of force, or the law of the Constitution. We shall not shrink from that great responsibility.

It is now less than two months since the election of Abraham Lincoln as President of the United States. In that time, the Southern states have seceded from the Union, and the Federal troops have been driven from the capital city of Washington, D.C. The Southern states have declared their independence, and are now at war with the United States.

The Southern states have taken this action because they are dissatisfied with the policies of the Federal government. They believe that the Federal government is trying to impose its will on them, and that they have no say in the matter. They also believe that the Federal government is not respecting their rights as citizens.

The Federal government, on the other hand, believes that it is fulfilling its constitutional duty to protect the rights of all citizens, regardless of where they live. It also believes that the Southern states have no right to secede from the Union, as this would violate the principles of democracy and self-government.

The situation is now at a standstill, with both sides refusing to back down. The Federal government has sent troops to defend the capital city, and the Southern states have responded by sending their own troops to try to capture it. The conflict is now at a critical point, and the outcome is uncertain.
