**DESCRIPTIONS**

(1) Section 147: **Punishment of rioting:-**

-Whoever is guilty of rioting, shall be punished with imprisonment of either description for a term which may extend to two years, or with fine, or with both.

(2) Section 294(b): **Obscene acts and songs-Whoever, to the annoyance of others—**

(b) signs, recites or utters any obscene song, ballad or words, in or near any public place,

Shall be punished with imprisonment of either description for a term which may extend to three months, or with fine, or with both.

(3) Section 506: **Punishment for criminal intimidation—Whoever commits, the offence of criminal intimidation shall be punished with imprisonment of either description for a term which may extend to two years, or with fine, or with both;**

If threat be to cause death or grievous hurt, or to cause the destruction of any property by fire, or to cause an offence punishable with death or [imprisonment for life], or with imprisonment for a term which may extend to seven years, or to impute, unchastity to a woman, shall be punished with imprisonment of either description for a term which may extend to seven years, or with fine, or with both.

(iv) Court which framed the charges: **Charges not yet framed by Hon'ble Judicial Magistrate No.2 of Tirupur.**

(v) Date on which the charges: **Charges not yet framed.**

(vi) Whether all or any of the proceedings have been stayed by any court of competent jurisdiction: **No.**

2. I have not been convicted of an offence referred to in sub-section (1) or sub-section (2), or covered in sub-section (3), of section 8 of the Representation of the People Act, 1951 (43 of 1951) and sentenced to imprisonment for one year or more.
