# Mumbai cops book EVM critic based abroad for fake claims

# Police Action Comes After Complaint By Top Poll Official In Maha

New Delhi: Acting on a complaint from Maharashtra chief electoral officer (CEO), Mumbai Cyber Police on Saturday night registered an FIR against foreign-based EVM basher Syed Shuja inconnection with a video showing him making "false, baseless and unsubstantiated claims" that he could hack and tamper EVMs in the recent Maharashtra polls by isolating their frequency.

Shuja was booked under Section 318(4) of the Bharatiya Nyaya Sanhita (BNS) and clauses 43(g) and 66D of the Information Technology Act. 2000.

Shuja, who Election Commission sources said is based in a "third country", was last in the news for having addressed in 21, 2019, with a handker-chief covering his face as he made similar claims that EVMs could be hacked by isolating their frequency, and that the 2014 Lok Sabha polls were vigged. He had, however, provided no proof in support of his

shocking claims. There are reports that Shuja is in the US. EC had taken serious note of Shuja's mischievous claims at the London press event — where interestingly, Congress leader Kapil Sibal was present — timed months ahead of the 2019 Lok Sabha polls. It had then directed Delhi police to file an FIR against him under Section 505 (1)(b) of the Indian Penal Code, which deals with acts of public mischief through circulation of content that may cause fear or alarm in the public.

Though Delhi police has, through the ministry of external affairs, repeatedly approached relevant authorities "in the third country" for help to investigate Shuja, there has been no forward movement on

the other end. Sources in EC said while access to Shuja may be dependent on cooperation of a foreign govt, both Delhi and Mumbai police will take all possible steps to identify and apprehend anyone within India who is in contact with individuals like Shuja or complicit in their malicious activities.

"Such actions are a serious offence, and no one who is involved will be spared," a senior EC official told **TOI**.

Regarding his latest video offering to hack EVMs in the Maharashtra polls for a hefty payment by isolating their frequency, which he claimed would alter the result, the Maharashtra CEO office clarified in a post on X on Sunday that the EVM being a standalone de-

vice, "cannot be connected to any network including any Wi-FI or any Bluetcoth by any person whatsoever". "Therefore, question of manipulating EVMs does not arise. EVMs are completely tamper-proof," it said.

Recalling that Supreme Court has time and again reposed faith in EVMs, the post on X also mentioned the FIR registered by Delhi Police against Shuja in 2019 on EC's directions.

Section 318(4) of BNS - under which Shuja has been booked - states that whoever cheats and dishonestly induces a person to be deceived to make, alter or destroy anything which is signed or sealed, shall be punished with imprisonment up to seven years, with a fine. While clause 43(g) of the IT Act makes it illegal to help someone access a computer resource in viola-tion of the Act and its rules, clause 66D deals with cheating by personation by means of any communication device or computer resource, punishable with a jail term of up to three years and a fine up to ₹1 lakh.

#### Now, CPM MP asks EC to clarify Maha poll percentage surge

THIRUVANANTHAPURAM: Thiruvananthapuram: CPM Rajya Sabha MP John Brittas on Sunday wrote to the Election Commission of India stating that there is an "urgent need" for clarification on alleged discrepancies in voter turnout percentage of the recently concluded Maharashtra Assembly polls. The letter by Brittas has come two days after the Congress raised with the EC "serious and grave inconsistencies" which it said were being revealed in the data relating to the polling and counting processes for the Maharashtra elections. Responding to the issue regarding the voter turnout data, the EC on Saturday asserted that there was no discrepancy in it and the data was available with all candidates polling station-wise and is verifiable. In the letter addressed to Chief Election Commissioner Rajiv Kumar, Brittas said certain allegations have recently emerged in the public domain regarding voter turnout figures and post-poll patterns, particularly in the context of the Maharashtra Assembly elections.

# More voters per booth: SC to hear plea on EC move

NEW DELHI: The Supreme Court is scheduled to hear on December 2 a PIL challenging the Election Commission's decision to increase the maximum number of voters per polling station from 1,200 to 1,500.

A Bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar will take up the PIL filed by one Indu Prakash Singh, who has challenged two communications issued by the Election Commission in August 2024 increasing the number of voters per polling stations in each constituency across India.

Singh has contended that the decision to increase the number of voters per polling booth was arbitrary and not based on any data.

On October 24, the top court refused to issue any notice to the poll panel but allowed the petitioner to serve the copy to the standing counsel of the Election Commission so that its stand on the issue is known.

Senior advocate Abhishek Singhvi, appearing for the petitioner, contended that increasing the num-

ber of voters from 1,200 to 1,500 would lead to the exclusion of underprivileged groups from the electoral process as it will take a longer time for an individual to cast their franchise.

He had also submitted that longer queues at the polling station and longer waiting periods would dissuade voters from going to cast their votes.

The bench said the poll panel wants more and more people to vote and with the use of EVMs, it takes a shorter time compared to ballot papers, addding.

it is trying to reduce the time taken to cast votes by increasing the number of EVMs at booths.

The petitioner has contended that the poll pan-

el's decision would impact the voters during the assembly elections in Maharashtra and Jharkhand (since concluded) and Bihar and Delhi to be held next year.

Singh said that elections are normally held for 11 hours and it takes around 60 to 90 seconds to cast one vote, and therefore 660 to 490 persons can cast their vote in a day at one polling station with one EVM.

While the Election Commission has denied the claims, it has also registered a complaint with the Mumbai cyber police in this regard. In the viral video, a man on a video call explains how he can allegedly manipulate and tamper
with the EVMs in the

that he has "access" to 281 out of 288 seats, though he adds that "frequency isolation is not possible" in some regions. He also mentioned that ₹52-53 crores will be charged for allegedly ensur-ing victory in 63 seats. The complaint was lodged by the Maharashtra chief electoral officer, alleging that the claims made by the accused, Syed Shuja, were false and unsubstantiated. The FIR was registered under the Bharatiya Nyaya Sanhita and the IT Act at the Cyber Police Station, Dakshin Mumbai on November 30 "against the person in this video", the CEO said. FI
