#### **ORDER:**

The Government have decided to declare Friday, the 13<sup>th</sup> February, 2015 as a Public Holiday for the areas comprised in 139.Srirangam Assembly Constituency lying in Tiruchirappalli and Pudukkottai Districts in connection with the Bye-election to Tamil Nadu Legislative Assembly from 139.Srirangam Assembly Constituency.

#### **NOTIFICATION**

Under the Explanation to Section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881), read with the Notification of the Government of India, Ministry of Home Affairs, No.20-25-26, Public-I dated the 8<sup>th</sup> June, 1957, the Governor of Tamil Nadu hereby declares Friday, the 13<sup>th</sup> February, 2015, the date on which the poll for the Bye-election to Tamil Nadu Legislative Assembly from 139.Srirangam Assembly Constituency will take place, to be a public holiday for the areas comprised in the above Assembly Constituency lying in Tiruchirappalli and Pudukkottai Districts.

2. Further, all employees working in Tiruchirappalli and the neighbouring Pudukkottai districts but registered as voters in 139.Srirangam Assembly Constituency, shall also be given a paid holiday on 13.02.2015.

All Government offices including industrial establishments of the Government and Government controlled bodies and all the educational institutions throughout the area comprised in 139.Srirangam Assembly Constituency lying in Tiruchirappalli and Pudukkottai Districts will remain closed on 13.02.2015.
