- 5. This must be delivered to the returning Officer and the Chief Electoral Officer not later than 3.00 p.m/ on the last date for making nominations.

2. Form must be signed in ink by the office bearer(s) mentioned above. No facsimile signature or signature by means of rubber stamp. Etc., of any office bearer shall be accepted.

3. No Form transmitted by fax shall be accepted.

4. Para 2 of the Form must be scored off. In not applicable, or must be properly filled, if applicable.
